Subject: Erasmus+ call for proposals 2020

Distinguished Presidents of Regional Conferences,

Following the announcement of the Erasmus+ call for proposals for the year 2020, by the European Union's Executive Agency, the National Office of Erasmus+ (NEO) Algeria is honoured to send you this correspondence in order to publish the aforementioned announcement on a wide level within Algerian Higher Education Institutions (HEIs).

We are pleased to inform you that the Erasmus+ call for proposals for the year 2020 was published in November 2019, and is set to expire in February 2020 according to the calendar of each Erasmus+ activity which is attached to this correspondence (Attachment 1)

Algeria -A partner country of Region 3 (South-Mediterranean countries)- is eligible to participate along with programme countries* for the International Dimension of the Erasmus+ programme which contains the following activities: "International Credit Mobility (ICM)" for students, academic and administrative staff of Higher Education Institutions, "Erasmus Mundus Joint Master Degrees" scholarship offers, "Capacity Building in Higher Education (CBHE)" according to the national priorities for higher education sector, and finally Jean Monnet specific activities.

Regarding the financial envelopes of the Erasmus+ programme, detailed in the attached document (Attachment 2), Algeria has benefited, in addition to the total budget of around 31 million € dedicated for Region 3, from a 5 million € grant from the European Commission within the framework of the EU-Africa Alliance, JUNKER Special Window dedicated to International Credit Mobility, Algeria also benefited from a special window North Africa grant of an amount of 2.5 million € for the year 2020.

*Note: Programme countries of the Erasmus+ programme are all 28 EU member countries (Spain - Germany - Italy - Portugal - Belgium - Luxembourg - France - Sweden - Denmark - Finland - Austria - Netherlands - Greece - England - Ireland - Hungary - Czech Republic - Poland - Slovakia - Slovenia - Lithuania - Latvia - Estonia - Malta - Cyprus - Romania - Bulgaria - Croatia) in addition to Liechtenstein, North Macedonia, Iceland, Norway, Serbia and Turkey.
